I am aware that visa rejection does not imply any right to the refund of the consular fee.

In case of multi-entry visa request, I am aware that I need to be in possession of a valid health travel insurance for any trip in the Schengen area.

I am informed and accept that the required collection through the present form, my photo and, if applicable, the acquisition of my fingerprints are necessary for the evaluation of the visa request and that my personal data in the form, my fingerprints and my photo will be forwarded to the competent Member States' Authorities, which will deal with them in order to adopt a decision on my request.

Such data and the data concerning the decision on the visa application or any decision whether to annul, revoke or extend a visa issued shall be entered and stored in the Visa Information System (VIS) for a maximum period of five years, during which period they shall be accessible to the visa authorities, to those competent for carrying out visa checks at the external borders and within the Member States and to the immigration and asylum authorities in the Member States for the purposes of verifying whether the conditions for legal entry, stay and residence on the territory of the Member States are fulfilled, identifying persons who do not, or no longer, fulfil these conditions and examining an asylum application and designating the authority responsible for such examination. Under certain conditions, the data will also be accessible to the designated authorities of the Member States (for Italy, the Ministry of the Interior and the police authorities) and to Europol for the purposes of the prevention, detection and investigation of terrorist offences and other serious criminal offences. The Ministry of Foreign Affairs and International Cooperation - MAECI (Piazzale della Farnesina 1, 00135 Rome) www.esteri.it telephone 0039 06 36911 (switchboard), through the Italian diplomatic mission or consular post with which the visa application has been lodged, is the Member State authority responsible for data processing.

I am informed of my right to obtain, in any Member State, communication of the data relating to me recorded in the VIS and of the Member State which transmitted it, and of my right to request that inaccurate data relating to me be corrected and that unlawfully processed data relating to me be deleted. At my express request, the authority examining my request (for the Italian diplomatic mission or consular post see www.esteri.it and <http://vistoperitalia.esteri.it>) will inform me of how to exercise my right to check my personal data and have them corrected or deleted, and of the remedies provided for in this respect by the national law of the Member State concerned. The Italian national supervisory authority competent to hear complaints on the protection of personal data is the Personal Data Protection Officer (DPO) of MAECI (email: rpd@esteri.it, pec: rpd@cert.esteri.it) or, alternatively, the "Garante per la Protezione dei Dati personali" (Piazza Venezia 11, 00187 ROMA; tel. 0039 06 696771 (switchboard); email: garante@gpdp.it; pec: protocollo@pec.gpdp.it). I declare that, to the best of my knowledge, all the information I have provided is complete and accurate. I am aware that false statements will lead to the rejection of my application or the annulment of the visa already granted, and may result in legal action under the law of the Member State processing the application. I undertake to leave the territory of the Member States before the expiry of the visa, if granted. I am informed that possession of a visa is only one of the conditions necessary for entry into the European territory of the Member States. The mere granting of a visa does not entitle me to compensation if I do not fulfil the conditions laid down in Article 6(1) of Regulation (EU) No 2016/399 (Schengen Borders Code) and I am therefore refused entry. Compliance with the entry conditions will be checked again when entering the European territory of the Member States.
